GUEST AGREEMENT

This agreement is between PEACE HILL FARM PET BOARDING & GROOMING, LLC and the PET OWNER/GUARDIAN whose signature appears below.

Peace Hill Farm Pet Boarding & Grooming shall exercise due and reasonable care for each pet while it is on our premises. Under this reasonable care, Owner releases Peace Hill Farm Pet Boarding & Grooming from, and waives all claims and liability against Peace Hill Farm Pet Boarding & Grooming for or attributable to injury or illness of pet.

Peace Hill Farm Pet Boarding & Grooming requires that all pets be vaccinated against communicable diseases prior to boarding/grooming. For dogs this includes, Rabies, Bordetella (kennel cough), DHPP, (Distemper, Hepatitis, Parainfluenza, & Parvovirus.) For cats this includes Rabies & any others recommended by your veterinarian such as FPV, FHV1 or FCV. A copy of current vaccination records are required prior to or upon check in.

Peace Hill Farm Pet Boarding & Grooming reserves the right to refuse service at its discretion.

Peace Hill Farm Pet Boarding & Grooming does not board or groom pets with behavior problems that are deemed a safety risk for other boarding pets, staff or itself. We will provide medications & treatments as per your specific instructions. However, we want you to understand that we are not veterinarians or technicians. If your pet becomes ill or injured, we may engage the services of a local veterinarian or provide appropriate medical attention to the animal in order to keep it stable. Owner authorizes the release of said pet's medical records from pet's veterinarian.

Owner agrees to pay all fees for boarding, grooming and other services/treatments incurred during pet's stay at Peace Hill Farm Pet Boarding & Grooming. Pet shall not leave Peace Hill Farm until all fees are paid. Pet will not be released to anyone other than the owner without prior approval.

Payment is by cash or check only.

In the event a reservation needs to be cancelled, the Owner will notify Peace Hill Farm Pet Boarding & Grooming as soon as possible or you could be assessed a fee.

Owner acknowledges that there are certain risks involved with pet ownership and care. Including, but not limited to, the unpredictability of a pet's reaction to unfamiliar objects, surroundings, persons and other animals, fighting, biting, and the transmission of disease. Owner accepts the risks involved and agrees that Owner shall be solely responsible for any and all acts and behaviors of said pet while it is in the care of Peace Hill Farm Pet Boarding & Grooming.

Owner agrees to disclose to Peace Hill Farm Pet Boarding & Grooming all known medical and behavioral problems which may affect pet's care and/or staff prior to check in.

Owner agrees that pet is healthy and has not been exposed to any know communicable disease within the 30 days prior to boarding/grooming.

All pets will be inspected upon arrival and check-in. Any pet with flea/tick problems will be immediately treated with oral Capstan/a bathing product/topical medication. If a pet has a medical reason NOT to receive these treatments please indicate so.

Owner agrees that any photographs, videotapes or recordings of pet taken while at Peace Hill Farm Pet Boarding & Grooming shall be solely owned & copyrighted by Peace Hill Farm Pet Boarding & Grooming and may be used for promotions and advertising.

By signing this contract Owner agrees to abide by all of the Peace Hill Farm Pet Boarding & Grooming Rules, Regulations and Policies.
